

## The Program

The **DUBLIN CRIME FREE MULTI-HOUSING PROGRAM** is designed to help tenants, owners, and managers of rental property keep drugs and other illegal activity off their property.

The program is solution-oriented and designed to be easy, yet very effective in reducing the incidence of crime on rental property.

The program utilizes a three part approach which ensures the crime prevention goal while maintaining an approach which is very tenant-friendly.

**Phase One** is an 8-hour training seminar for property managers presented by the police department. Topics include tenant screening, crime prevention, evictions and drug/gang recognition. Attendees receive a certificate upon completion.

**Phase Two** is a security assessment of the rental property to certify that minimum safety requirements have been met.

**Phase Three**, conduct a Safety Social for residents and the property then receives full certification.

## Environmental Design

### (CPTED)

**CPTED is the use of design to eliminate or reduce criminal behavior while at the same time encouraging people to "keep an eye out" for each other. The key principles are: Natural Surveillance, Access Control, Territoriality, Maintenance and Activity Support.**

**Minimum CPTED requirements for Crime Free Certification:**

- 180-degree eye viewers in front door;
- Deadbolts and 3" screws in strike plates;
- Secondary locks on windows and sliding glass doors;
- Proper landscaping;
- Sufficient lighting
