

### WHO NEEDS A BUSINESS LICENSE?

Any entity or person doing business in the City of Dublin (including subcontractors and landlords) must have a current Business License. This includes home-based businesses, as well as those in commercial areas. It also includes businesses that come to Dublin from a different City and provide services or deliver goods for a fee. Business Licenses must be obtained within 30 days of the starting date of your business, otherwise your business will be subject to additional late fees (See Businesses Exempt from Business License Fees on back panel).



Businesses pay a yearly \$50 registration fee due October 1st of each year. This fee is prorated on a monthly basis for the first year a business begins operation in Dublin. In addition, some businesses are subject to an annual \$11 Fire Department Self Inspection Fee. Please contact the Fire Department at (925) 833-6606 if you have any questions regarding the Self Inspection Fee. The City's Business License year begins on October 1st and ends on September 30th. BUSINESS LICENSE FEES ARE NON-REFUNDABLE.

### FREQUENTLY ASKED QUESTIONS REGARDING BUSINESS LICENSES

*How long does it take to obtain a Business License?*

Because Business License applications are subject to review by several City Departments, it may take 6-8 weeks from the date the application is received by the City to obtain a Business License.

*Do I need a new license if my business changes its location, ownership or name?*

If your business moves to another location within the City, you will need to submit a new application and pay a prorated fee based upon the date your business relocated. If the name or ownership of the business has changed, an application noting the change must be submitted.

*What other approvals are needed in addition to a Business License?*

All businesses must obtain approvals from their property manager and check with the Planning Division for any additional requirements prior to applying for a Business License. For example, Taxi Cabs, Fortunetellers, Ice Cream and Catering Trucks, Second Hand Dealers, Door to Door Salespersons and Massage Establishments need to register with Dublin Police and obtain a Permit. Day care (9 children or more), Fortunetellers and Massage Establishments need a Conditional Use Permit. In addition, all home occupations must comply with the Dublin Zoning Ordinance Home Occupation Regulations and complete a supplemental home occupation form.



*Can I use a Post Office box for my address?*

A Post Office Box is only valid as a mailing address. You must supply the City with the physical location address of your business.

*What if I am late with my payment?*

If the payments for annual renewals are received after November 1st of each year, or 30 days after the start of business for a new business, an additional penalty of 7% per month, up to a maximum of \$50 per year, will be added to the amount due.

*How can I verify if a business has a current license?*

Contact the Community Development Department at 833-6620 and they will verify if the business has a current license.

*How do I renew my license?*

Renewal notices are mailed out in September and are due by October 30th. If you are no longer conducting business within the City, please indicate on the renewal form and return to City Offices.

*What is the cost of a replacement Business License?*

It costs \$5 to obtain a replacement copy.

### BUSINESS EXEMPT FROM FEES

The following types of businesses are exempt from the payment of Business License fees, although a City Business License application may need to be filed:

- Agriculture, Attorneys and Banks
- Charitable Organizations exempt from taxes under IRS Code 501(c) - a formal ruling from the IRS will be required

- Disabled Veterans
- Federal and State Entities
- Insurance Companies
- Inter-city freight carriers exempt under the Highway Carriers Business License Act
- Nonprofit Activities
- Part Time Workers under the age of 18 or over the age of 65
- Cafe Musicians
- Commercial Travelers
- Real Estate Auctioneers
- Persons renting, leasing or operating laundry equipment which is NOT owned and operated by a retail establishment
- Persons renting, leasing or operating coin-operated vending machines
- Individual purveyors operating under a master Business License obtained by an organizer of a festival, fair, farmers' market or similar event
